Ola, Legazpi City and respective Provincial Supply Accountable Officer.

Prospective bidders are required to submit in a sealed long brown envelope their bid proposal together with a refundable bid bond of minimum 10% of the bid proposal of the items to be bid out in the form of Cash following the sample markings below:

Bids that are not in the prescribed form, without authenticated photocopy of Valid **Mayor's Permit** and/or **Business Permit** and those not accompanied or guaranteed by bid bonds at the time of opening of bids are considered defective bids and shall be automatically disqualified.

Prospective bidders shall submit one (1) Bid Form for every lot item to be bid.

The amount of Bid should be indicated in numeric and in words. In case there is discrepancy between the two, the amount in words should prevail.

When two or more complying bidders made identical offers, public auction viva voce between those who made identical bids shall be resorted to at a price not less than the offered bids.

The bid bond will be returned to the losing bidders after the declaration of the winning bidder.

The bid bond of the winning bidder shall be deposited at the Regional Finance Service Office 5 (RFSO5).

The winning bidder shall pay the corresponding amount of bid minus the bid bond at the Regional Finance Service Office 5 at Camp BGen Simeon Ola, Legazpi City within five (5) working days upon receipt of the Notice of Award.

Failure of the winning bidder to pay the corresponding bid amount within the reglementary period of five (5) working days from the date of the Notice of Award, will result in the forfeiture of the bid bond in favor of the government.

Pursuant to COA Memorandum Circular No. 89-296 dated January 27, 1989, there must be more than one (1) bid tender submitted per lot, otherwise, the envelope containing the bid tendered for the lot shall not be opened, and the bid shall be considered failed.

Bid proposals lower than the floor price will be automatically disqualified.

A Notice of Award shall be given to the highest complying bidder.

The awardee shall collect/remove the items included in the lot after the bid price is fully paid as evidenced by an Official Receipt (OR) and shall be made only from 8:00 AM to 5:00 PM during Mondays to Fridays and within Thirty (30) days after the award. Failure on the part of the awardee to remove the property within the stipulated period shall have the effect of cancellation of award/contract.

The provisions of the PNP Memorandum Circular No. 2017-017 dated February 21, 2017 "Revised Guidelines and Procedures in the Disposal of PNP Property, Plant and Equipment (PPE) and the Disposition of the Income Derived Therefrom" shall govern all particulars relative to Bid Evaluation and Award.

The Police Regional Office 5 Disposal Committee reserves the right to reject any or all the bids, waive any required formality and accept the offer most advantageous to the government. Likewise, assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of the bid.
